## Property Investing for Retirement . . . .

• Lower capital gains tax if you sell the investment property after 12 months.

• If drawing a pension from your self managed super fund, capital gains tax can be tax-free.

Although the process is more complicated than buying an investment property straight up the benefits later in life can be well and truly worth it.

There are plenty of places throughout Australia that are investment hot spots - look for places with booming infrastructure and development such as in and around mining towns and low rental vacancy rates. Talk to your local Professionals real estate agent about investment opportunities available in your area.
